IN CONSIDERATION OF VENTURA RACING ASSOCIATION GRANTING ME A LICENSE TO PARTICIPATE IN SANCTIONED EVENTS, AND TO COMPETE FOR PRIZE MONEY, OR TO ENJOY PARTICIPATION IN SCHEDULED SPORTING EVENTS, I HEREBY GRANT TO SAID VRA, AND TO ITS DESIGNEE:

- All fees, salaries, or other remuneration including residuals, derived from any movie films, television, radio, advertising or other entertainment media derived from my activities as a participant in any VRA sanctioned event.
- The exclusive right to publish, sell or use in any fashion, photographs of me or my equipment, without remuneration, or notice to me.
- A complete and unconditional release on behalf of myself and my heirs for any injury sustained by me while participating in any sanctioned event, and/or damage to my property sustained while participating in any sanctioned event.

AS A CONDITION UNDER WHICH VRA AGREES TO ISSUE ME A LICENSE TO PARTICIPATE IN SANCTIONED EVENTS I AFFIRM THE FOLLOWING REPRESENTATIONS:

- My participation in any sanctioned event shall be on a voluntary basis, in which event I shall be acting solely for myself as an independent contractor. I will not act as an agent, servant or employee of VRA or any other person or organization if I participate in an event.
- If, as a result of voluntary participation in any sanctioned event, I win any prize money, I do so as an independent contractor and will maintain all necessary records and file all necessary tax returns.
- As a voluntary participant in any sanctioned event, acting solely on my behalf as an independent contractor, I recognize the fact that VRA does not provide Workman's Compensation Insurance, Unemployment Disability Insurance, Federal Old Age Survivor's Insurance, Medicare, or any State or Federal Taxes.
- As a voluntary participant in any sanctioned event, I fully recognize to possibility of injury to my person and damage to my property, and I freely assume these risks as a participant in any sanctioned event.
- I hereby agree to support all VRA sanctioned events, and not to engage in any demonstrations, strikes, boycotts, or any activities which might be considered detrimental to VRA or motor sports.
- I hereby agree to abide by all rules and regulations set forth in the official VRA Rules and Bulletins, and I further agree to accept the decisions rendered by the VRA Race Director as a final in all cases.
- I have read and understand this application for a participant's license. I fully understand the application contains a general release to all persons in any way connected with a sanctioned event for any injuries I sustain or damage to my property.
- VRA reserves the right to approve or reject any and all license applications.
